



**2021 Sumer Camp Participant Tent Overnight Waiver -Missouri Camps Only**

To mitigate the spread of COVID-19, we require all Scouts and adults, who are not fully vaccinated\* to tent alone during overnight summer camps. However, this form gives permission for two Cub Scouts, Scouts BSA members or Venturers who are not fully vaccinated to tent together if the parents/guardians of each camper consent. In accordance with Youth Protection Requirements of the Boy Scouts of America, Scouts of more than two years difference in age are not allowed to camp together. Even with signing this form, this requirement must be kept. This form must be signed prior to the start of camp and will be reviewed upon check-in.
